Lieutenant Russell Poole was only 45 years old last Thursday when his wife went to wake him and found that he had died sometime in the night. Lt. Poole had come up through the ranks of our Police Department from patrolman to lieutenant. He will be greatly missed. I think that in the dictionary, beside the words, "Good Policeman", is a picture of Russell. Besides being a good officer, Russell was a good person that has been a help and good friend to many of us in Edmundson. Lt. Poole's funeral will be held this Saturday the 4th @ Kutis Funeral Home on Lemay Ferry Rd. At the conclusion of services, the procession will circle through Edmundson for anyone that wishes to show their respects but unable to attend the funeral. The procession should reach Edmundson about 3:30 – 3:45PM. The city's sympathy goes out to Russ's fellow officers, fellow employees, and to his family. My prayer is for the Lord to comfort Russ's family during this difficult time as only He can.
